

**APPLICATION TO PARTICIPATE IN THE
COMMITMENT TO COMPLIANCE (CTC) SCHEME**

The SA Olive Commitment to Compliance (CTC) Scheme for locally produced extra virgin olive oil is a voluntary integrity-based scheme aimed at providing the South African consumer with reassurance regarding the quality of olive oils carrying the compliance seal and therefore a meaningful reason for supporting the local industry.

The CTC seal is primarily intended for finally packaged and labelled products. Members may submit for assessment either (a) finally packaged and labelled products, and/or (b) “Tank Samples” before final packaging and labelling.

It shall be within the sole discretion of SA Olive whether or not to accept an application, and/or to permit the use of the CTC seal on or in association with any olive oil. The acceptance of an application or permission to use the CTC seal is not a legally binding guarantee by SA Olive that either the product or any aspect of its packaging and/or labelling complies with any applicable laws, regulations or standards.

 - a. is a member of SA Olive in good standing, or has applied to become a member;
 - b. undertakes to comply with all laws and regulations that apply to the production and labelling of olive oil, and all quality standards required by SA Olive;
 - c. Consents to SA Olive taking any action it considers appropriate to protect the integrity of the CTC scheme;
2. The samples submitted for evaluation consist entirely of olive oil produced in South Africa.

A Tasting Report will be issued for each sample. The report will indicate whether the sample is extra virgin according to organoleptic assessment and will include tasting notes.

The cost of the Tasting Report is: R 300 (excl VAT) per sample.

SECTION E: APPLICATION CHECK LIST

The following must be included with this application:

1. Certificate of chemical analysis including free fatty acid and peroxide values for each sample;
2. 2 x olive oil sample bottles (min 250 ml) for organoleptic tasting purposes, with date of sampling;
3. Copy of front and back label with lot/batch number and best before date clearly indicated.

SECTION F: SUBMISSION AND PAYMENT

The completed application must be **sent by email** to SA Olive (info@saolive.co.za) before 12 noon **on the Friday prior** to the Monday tasting. Please refer to the **CTC Tasting Dates** on the SA Olive website. No late submissions will be accepted.

The completed application must be **submitted with the samples**.

SAMPLES WITH INCOMPLETE PAPERWORK WILL BE HELD OVER UNTIL ALL DOCUMENTATION HAS BEEN RECEIVED.

Invoices will be issued after the tasting session and seals will be invoiced after collection. All invoices are payable on presentation. Seals will only be issued if the previous order has been paid in full.
